

PRESSION OF INTEREST (EOI) FOR ENGINEERING/ARCHITECTURAL CONSULTANT FIRM(S) FOR PLANNING & DEVELOPMENT PROJECTS

Khwaja Fareed University of Engineering & Information Technology, Rahim Yar Khan (KFUEIT) has been established under the auspices of the Government of the Punjab.

The Project envisages the establishment of a state of art University for the providing educational facilities in the fields of engineering and information technology. The phase -1 of the project was constructed over an area of 200 acres located at Abu Dhabi Road, Rahimyar Khan. Phase -2 of the project is being planned on additional land (200 acres) acquired adjacent to the existing campus.

- 4. List of permanent professional staff along with CVs of relevant core staff showing project wise experience with exact time duration of each project supported with appointment letters and pay slips/salary vouchers to authenticate employment of the personnel with the applicant form.
- 5. List of similar works/projects completed by the firm within past 05 years with their total cost and or works in hand indicating cost of each work supervised by the firm and cost of consultancy received against the assignment along with date of start and completion or expected date of completion supported with performance certificate(s) from the employer(s).
- 6. Financial position of the firm supported with authenticated financial statement (s) from financial institution/Regulatory bodies. Audited statements of accounts of the firm for the last three (03) years.
- 7. Managerial Capability of the firm.
- 8. Affidavit/Certificate that the firm was not black listed by any Government/Semi Government Department/Institution.
- 9. Affidavit/Certificate that the firm is not involved in any litigation.

Interested firm may be obtain/purchase set of pre-qualification documents/criteria for shortlisting/prequalification on a written request from the office of the undersigned on payment of Rs. 2000/- (Rupees Two Thousand only) in the form of Pay Order/Bank Draft in the favor of <u>KFUEIT,RYK</u> on any working day up to one day prior to the closing date.A copy of pre-qualification document is available for information and can be downloaded from the website <u>www.kfueit.edu.pk</u> or <u>www.ppra.punjab.gov.pk</u>. In case the pre-qualification document is downloaded from websites, the required cost of bidding document shall be submitted with document in form of Pay Order/Bank Draft. **Only pre-qualified /shortlisted firms shall be entitled to participate in the subsequent selection proceedings.**
