1. Name of firm with year of establishment, NIC/NTN, partnership deed, valid address and telephone numbers of Owners (s), persons dully authorized through registered power of attorney for future correspondence.
2. Full bio-data/list of technical staff engaged with the firm along with proof.
3. Details of works similar nature on-going/executed during last five years indicating project cost, completion time, quality of work, performance/efficiency verified from concerned Engineer In-charge (Contract Signing Authority) Head of Engineering Department.
4. Bank certificate, limits and bank statement of accounts for FY 2018-19 clearly indicating credit worth.
5. Detail(s) of arbitration/litigation or similar proceeding against Government/Autonomous and Semi-Govt Department(s) showing extant and results.
6. Proof of enlistment/renewal with Government/Autonomous and Semi-Govt. Department(s).
7. Undertaking on judicial paper signed by the owner/authorized persons that the firm is never black listed or debarred by any of Government/Autonomous and Semi-Govt. Department(s); there is no concealment of fact/information/detail; will abide by all the rules and regulation of the Khwaja Fareed University of Engineering and Information Technology, Rahim Yar Khan and time to time amendments (helping format both for individual & partner firms available on website:[www.kfueit.edu.pk](http://www.kfueit.edu.pk)).
8. Valid partnership deed, Articles of Association and Memorandum (in case applicable).
9. Any other document which deems necessary.

**Rules & Regulations:**

2. University authorities/enlistment committee reserves the right to reject all application(s) as per PPRA Rules.

5. The technically responsive firms will have to deposit the enlistment fee for the FY 2019-20 with in stipulated time and will be considered for renewals for next Financial Years subject to their performance, quality of work etc.
